26 September 2024, 6AM

I. Situation Overview

On 16 September 2024 at around 2:48 PM, a fire incident occurred at Sitio Tigis, Brgy. Tigum, Buruanga, Aklan. The fire was declared out at around 3:40 PM.

A total of **two (2) families** or **17 persons** were affected in **Brgy. Tigum, Buruanga, Aklan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **17 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) is totally damaged and one (1) is partially damaged in Brgy. Tigum, Buruanga, Aklan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,292.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
