





DSWD DROMIC Report on the Whirlwind Incident in Brgy. Bungro, Magsingal, Ilocos Sur

25 September 2024, 6AM

I. Situation Overview

On 25 July 2024 at around 9:50 AM, a whirlwind incident occurred in Brgy. Bungro, Magsingal, Ilocos Sur that caused partial damages to several houses in the area.

II. Status of Affected Areas and Population

A total of **two (2) families** or **six (6) persons** were affected in **Brgy. Bungro**, **Magsingal**, **Ilocos Sur** (see Annex A).

III. Damaged Houses

Two (2) houses were partially damaged in Brgy. Bungro, Magsingal, Ilocos Sur (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱32,984.20 worth of assistance was provided to the affected families; of which, ₱22,984.20 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex C).
