

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Batiarao, Anda, Pangasinan

12 October 2024, 6AM

I. Situation Overview

On 23 August 2024 at around 7:00 PM, a fire incident occurred in Brgy. Batiarao, Anda, Pangasinan. The fire was declared out at around 7:15 PM.

One (1) family or **four (4) persons** were affected in **Brgy. Batiarao, Anda, Pangasinan** (see Annex A).

Outside Evacuation Center

One (1) family or **four (4) persons** are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Batiarao, Anda, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱15,692.70** worth of assistance was provided to the affected family; of which, **₱12,692.70** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
