12 October 2024, 6AM

I. Situation Overview

On 23 August 2024 at around 7:00 PM, a fire incident occurred in Brgy. Batiarao, Anda, Pangasinan. The fire was declared out at around 7:15 PM.

Outside Evacuation Center

One (1) family or four (4) persons are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Batiarao, Anda, Pangasinan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱15,692.70 worth of assistance was provided to the affected family; of which, ₱12,692.70 from DSWD and ₱3,000.00 from the Local Government Unit (LGU) (see Annex D).
