



# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Ketegan, Bautista, Pangasinan

29 September 2024, 6AM

# I. Situation Overview

On August 26, 2024, at around 1:21 p.m., two (2) residential houses were completely destroyed by fire in Barangay Ketegan, Bautista, Pangasinan, due to faulty electrical wiring.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office in Region I, together with the Local Government Unit of Bautista, Pangasinan, promptly provided relief and financial assistance to meet the immediate needs of those affected.

Two (2) families or seven (7) persons were affected in Brgy. Ketegan, Bautista, Pangasinan (see Annex A).

Two (2) families or seven (7) persons temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**Two (2) houses** were **totally damaged** in **Brgy. Ketegan, Bautista, Pangasinan** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱50,475.20 worth of assistance was provided to the affected families composed of ₱40,475.20 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
