24 November 2024, 6PM

## I. Situation Overview

On 07 September 2024 at around 6:00 PM, a fire incident occurred at Purok 1, Sitio Bangngao, Brgy. Sacpil, Conner, Apayao. The fire was declared out at around 8:00 PM.
