



# DSWD DROMIC Terminal Report on the Tornado Incident in Basista, Pangasinan

29 September 2024, 6AM

# I. Situation Overview

On August 10, 2024, a tornado struck the barangays of Bayoyong and Navalat in Basista, Pangasinan, causing damages to homes and displacing families and individuals in the community.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office in Region I, together with the Local Government Unit of Basista promptly provided relief assistance to meet the immediate needs of those affected.

# II. Status of Affected Areas and Population

A total of **27 families** or **109 persons** are affected in **two (2) barangays** in **Basista**, **Pangasinan** (see Annex A).

### III. Damaged Houses

A total of **27 houses** were damaged; of which, **10** are **totally damaged** and **17** are **partially damaged** in **Basista**, **Pangasinan** (see Annex B).

## **IV.** Cost of Humanitarian Assistance Provided

A total of ₱351,748.20 worth of assistance was provided to the affected families composed of ₱267,748.20 from DSWD and ₱84,000.00 from the Local Government Unit (LGU) (see Annex C).
