
DSWD DROMIC Preparedness for Response Report #2 on the Observance of “UNDAS” 2024 as of 31 October 2024, 6PM

Situation Overview

All Saints' Day (November 1) and All Souls' Day (November 2) or more commonly known as “UNDAS” by Filipinos is an annual remembrance of the departed. “UNDAS” (also known as Todos los Santos, Araw ng mga Patay) is when families gather in cemeteries to visit their loved ones. They flock around the graves lighting their colorful candles, placing nicely decorated flowers, and offer their prayers as a way of remembering the life of the person. It has been a tradition Filipinos never missed.

The occasion is often treated as a reunion or banquet, with families bringing food and drinks and camping out all day or even overnight. It is an official, state-recognized holiday, so people get leave from school or work on these days. This occasion usually leads to the increased volume of people on the roads, cemeteries, sacred grounds, and other related areas around the country which may lead to the possible occurrence of human-induced disasters and/or natural disasters.

“UNDAS” is traditionally celebrated on the first and second day of November. This year, November 1 (All Saint’s Day) and November 2 (All Souls’ Day) will fall on Wednesday and Thursday respectively.

Weather Bulletin

Issued on 31 October 2024 at 5PM, Typhoon “Leon” has made landfall over Southeastern Taiwan. The center of the eye was estimated based on all available data 320 km North Northwest of Itbayat, Batanes (23.4 °N, 120.6 °E) moving Northwestward at 25 kph with a maximum sustained winds of 155 km/h near the center and gustiness of up to 255 km/h.

Track and Intensity Outlook

- After crossing the landmass of Taiwan, LEON will then turn northeastward over Taiwan Strait towards the East China Sea and exit the Philippine Area of Responsibility tonight or tomorrow early morning (1 November). A second landfall over mainland China is not ruled out during this period.
- LEON is forecast to further weaken throughout the forecast period due to land interaction and marginally favorable environmental conditions.

Status of Prepositioned Resources: Stockpile and Standby Funds

A total of **1,411,316** Family Food Packs (FFPs) amounting to **₱1,100,089,652.79**, and available food and non-food items (FNIs) amounting to **₱1,153,829,166.43**.
