





DSWD DROMIC Report #2 on the Fire Incident in Brgy. 775, Sta. Ana, Manila City

as of 19 October 2024, 6AM

I. Situation Overview

On 15 October 2024 at around 6:12 AM, a fire incident occurred at Onyx St. corner Zobel St., Brgy. 775, Sta. Ana, Manila City. The fire was declared out at around 12:09 PM.

II. Status of Affected Areas and Population

A total of **365 families** or **1,415 persons** are affected in **Brgy. 775, Sta. Ana, Manila City** (see Annex A).

III. Damaged Houses

A total of **365** houses were damaged; of which, **305** are **totally damaged** and **60** are **partially damaged** in **Brgy. 775**, **Sta. Ana, Manila City** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱1,229,320.00 worth of assistance was provided by DSWD to the affected families (see Annex C).
