I. Situation Overview

On 03 September 2024 at around 2:58 PM, a fire incident occurred in Brgy. Adgao, Tubungan, Iloilo. The fire was declared out at around 4:00 PM.

One (1) family or four (4) persons were affected in Brgy. Adgao, Tubungan, Iloilo (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Adgao, Tubungan, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱4,564.00 worth of assistance was provided to the affected family; of which, ₱3,978.00 from DSWD and ₱586.00 from the Local Government Unit (LGU) (see Annex D).
