# I. Situation Overview

On 03 September 2024 at around 2:58 PM, a fire incident occurred in Brgy. Adgao, Tubungan, Iloilo. The fire was declared out at around 4:00 PM.

**One (1) family** or **four (4) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Adgao, Tubungan, Iloilo** (see Annex C).

# V. Cost of Humanitarian Assistance Provided

A total of ₱4,564.00 worth of assistance was provided to the affected family; of which, ₱3,978.00 from DSWD and ₱586.00 from the Local Government Unit (LGU) (see Annex D).
