

DSWD DROMIC Report on the Fire Incident in Brgy. Agdahon, City of Passi, Iloilo

21 October 2024, 6PM

I. Situation Overview

On 19 September 2024 at around 9:00 AM, a fire incident occurred in Brgy. Agdahon, City of Passi, Iloilo. The fire was declared out at around 10:00 AM.

In response to the incident, the DSWD through its Field Office in Region VI promptly provided intervention to support the immediate needs of affected family and individuals through the provision of relief assistance.

One (1) family or five (5) persons were affected in **Brgy. Agdahon, City of Passi, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Agdahon, City of Passi, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱18,131.44** worth of assistance was provided to the affected family composed of **₱8,131.44** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
