I. Situation Overview

On 11 July 2024 at around 11:00 AM, a fire incident occurred in Brgy. Dulacac, City of Alaminos, Pangasinan.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Dulacac, City of Alaminos, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱20,908.64** worth of assistance was provided to the affected family composed of **₱17,348.64** from **DSWD** and **₱3,560.00** from the **Local Government Unit (LGU)** (see Annex D).
