I. Situation Overview

On 11 July 2024 at around 11:00 AM, a fire incident occurred in Brgy. Dulacac, City of Alaminos, Pangasinan.

One (1) family or five (5) persons temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Dulacac, City of Alaminos, Pangasinan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P20,908.64** worth of assistance was provided to the affected family composed of **P17,348.64** from **DSWD** and **P3,560.00** from the **Local Government Unit (LGU)** (see Annex D).
