

DSWD DROMIC Report on the Fire Incident in Brgy. Mambulac, Silay City, Negros Occidental

07 October 2024, 6PM

I. Situation Overview

On 14 September 2024 at around 1:30 PM, a fire incident occurred at Brgy. Mambulac, Silay City, Negros Occidental. The fire was declared out at around 3:38 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Silay City, provided relief assistance to support the immediate needs of the affected families.

II. Status of Affected Areas and Population

A total of **10 families** or **35 persons** were affected in **Brgy. Mambulac, Silay City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **10 families** or **35 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **10 houses** were damaged; of which, **six (6)** are **totally damaged** and **four (4)** are **partially damaged** in **Brgy. Mambulac, Silay City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱78,646.40** worth of assistance was provided to the affected families composed of **₱68,646.40** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
