I. Situation Overview

On 28 September 2024 at around 4:20 PM, a fire incident occurred in Brgy. Tiza, Roxas City, Capiz. The fire was declared out at around 5:00 PM.

A total of **two (2) families** or **six (6) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) is totally damaged and one (1) is partially damaged in Brgy. Tiza, Roxas City, Capiz (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱15,628.88** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
