I. Situation Overview

On 16 September 2024 at around 8:30 AM, a fire incident occurred in Brgy. Tono-an, Bugasong, Antique. The fire was declared out at around 10:15 AM.

One (1) family or three (3) persons were affected in **Brgy. Tono-an, Bugasong, Antique** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tono-an, Bugasong, Antique** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱8,298.00** worth of assistance was provided to the affected family; of which, **₱6,298.00** from **DSWD** and **₱2,000.00** from the **Local Government Unit (LGU)** (see Annex D).
