30 November 2024, 6AM

I. Situation Overview

On 11 October 2024 at around 4:42 PM, a fire incident occurred at Mahogany St. and Bacawan St., Brgy. 145, Pasay City. The fire was declared out at around 6:02 PM.

A total of **75 families** or **251 persons** were affected in **Brgy. 145, Pasay City** (see Annex A).

Inside Evacuation Center

A total of **75 families** or **251 persons** sought temporary shelter at the **Brgy. 145 Evacuation Center** in **Brgy. 145, Pasay City** (see Annex B).

IV. Damaged Houses

A total of **13 houses** were **totally damaged** in **Brgy. 145, Pasay City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱47,501.25** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
