I. Situation Overview

On 26 February 2024 at around 3:30 PM, a fire incident occurred at Purok 3, Brgy. 34-D, Poblacion District, Davao City. The fire was declared out at around 7:02 PM.

A total of **71 families** or **182 persons** sought temporary shelter at the **Kapitan Tomas Monteverde Central Elementary School** in **Brgy. 34-D, Davao City** (see Annex B).

A total of **12 houses** were **totally damaged** in **Brgy. 34-D, Davao City** (see Annex C).
