

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Irisan, Baguio City

27 January 2025, 6AM

I. Situation Overview

On 19 October 2024 at around 12:00 PM, a fire incident occurred at Purok 28, San Carlos Heights, Brgy. Irisan, Baguio City.

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or seven (7) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Irisan, Baguio City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱94,674.00** worth of assistance was provided to the affected family; of which, **₱52,174.00** from **DSWD** and **₱42,500.00** from the **Local Government Unit (LGU)** (see Annex D).
