

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tiep, Bani, Pangasinan

12 January 2025, 6PM

I. Situation Overview

On 29 June 2024, at approximately 2:56 p.m., a residential house in Zone 1, Brgy. Tiep, Bani, Pangasinan, was completely destroyed by fire, displacing a family of three individuals who sought temporary shelter with nearby relative.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region I, in coordination with the Local Government Unit (LGU) of Bani, Pangasinan, provided relief and financial assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in Brgy. Tiep, Bani, Pangasinan (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) family was totally damaged in Brgy. Tiep, Bani, Pangasinan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱31,954.64 worth of assistance was provided to the affected family composed of ₱21,454.64 from DSWD and ₱10,500.00 from the Local Government Unit (LGU) (see Annex D).
