





DSWD DROMIC Report #1 on the Fire Incident in Brgy. Gamut, Tago, Surigao del Sur

as of 16 November 2024, 6PM

I. Situation Overview

On 27 October 2024 at around 8:00 PM, a fire incident occurred at Purok Dahlia, Brgy. Gamut, Tago, Surigao del Sur. The fire was declared out at around 8:25 PM.

One (1) family or five (5) persons are affected in Brgy. Gamut, Tago, Surigao del Sur (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Gamut, Tago, Surigao del Sur (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P9,393.50** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
