

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Gamut, Tago, Surigao del Sur

as of 16 November 2024, 6PM

I. Situation Overview

On 27 October 2024 at around 8:00 PM, a fire incident occurred at Purok Dahlia, Brgy. Gamut, Tago, Surigao del Sur. The fire was declared out at around 8:25 PM.

One (1) family or **five (5) persons** are affected in **Brgy. Gamut, Tago, Surigao del Sur** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Gamut, Tago, Surigao del Sur** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,393.50** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
