## I. Situation Overview

On 24 September 2024 at around 7:25 PM, a fire incident occurred in Brgy. Andres Bonifacio, Cadiz City, Negros Occidental.

## IV. Damaged Houses

**One (1) house** was totally damaged in **Brgy. Andres Bonifacio, Cadiz City, Negros Occidental** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱57,668.00** worth of assistance was provided to the affected families; of which, **₱7,668.00** from **DSWD** and **₱50,000.00** from the **Local Government Unit (LGU)** (see Annex D).
