I. Situation Overview

On 24 October 2024 at around 03:19 AM, a fire incident occurred in Brgy. Apiat, Aurora, Isabela.

A total of **four (4) families** or **20 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were **totally damaged** in **Brgy. Apiat, Aurora, Isabela** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱104,402.00** worth of assistance was provided to the affected families of which, **₱64,402.00** from **DSWD** and **₱40,000.00** from the **Local Government Unit (LGU)** see Annex D).
