# I. Situation Overview

On 25 October 2024 at around 6:11 PM, a fire incident occurred in Brgy. Dangdangla, San Juan, La Union.

**One (1) family** or **six (6) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Dangdangla, San Juan, La Union** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱40,468.43 worth of assistance was provided to the affected family; of which, ₱20,026.35 from DSWD and ₱20,442.08 from the Local Government Unit (LGU) (see Annex D).
