I. Situation Overview

On 26 September 2024 at around 2:30 PM, a fire incident occurred in Brgy. Handumanan, Bacolod City, Negros Occidental. The fire was declared out at around 3:40 PM.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Handumanan, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,969.28.00** worth of assistance was provided to the affected family; of which, **₱7,469.28** from **DSWD** and **₱2,500.00** from the **Local Government Unit (LGU)** (see Annex D).
