## **DSWD DROMIC Report on the Fire Incident in Brgy. Igmaya-an, Salvador Benedicto, Negros Occidental**

15 November 2024, 6PM

### **I. Situation Overview**

On 30 October 2024 at around 10:00 AM, a fire incident occurred in Brgy. Igmaya-an, Salvador Benedicto, Negros Occidental.

**One (1) family or four (4) persons** were affected in **Brgy. Igmaya-an, Salvador Benedicto, Negros Occidental** (see Annex A).

### **III. Status of Displaced Population**

**One (1) family or four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Igmaya-an, Salvador Benedicto, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱8,166.00** worth of assistance was provided to the affected family; of which, **₱7,526.00** from **DSWD** and **₱640.00** from the **Local Government Unit (LGU)** (see Annex D).
