I. Situation Overview

On 18 November 2024 at around 3:05 PM, a fire incident occurred in Brgy. Inabasan, Cabatuan, Iloilo. The fire was declared out at around 4:00 PM.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Inabasan, Cabatuan, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,670.00** worth of assistance was provided to the affected family; of which, **₱2,670.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
