I. Situation Overview

On 18 November 2024 at around 3:05 PM, a fire incident occurred in Brgy. Inabasan, Cabatuan, Iloilo. The fire was declared out at around 4:00 PM.

One (1) family or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Inabasan, Cabatuan, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱12,670.00 worth of assistance was provided to the affected family; of which, ₱2,670.00 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
