I. Situation Overview

On 01 November 2024 at around 4:00 PM, a fire incident occurred in Brgy. Mansilingan, Bacolod City, Negros Occidental.

A total of **₱11,958.00** worth of assistance was provided to the affected family; of which, **₱7,668.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).

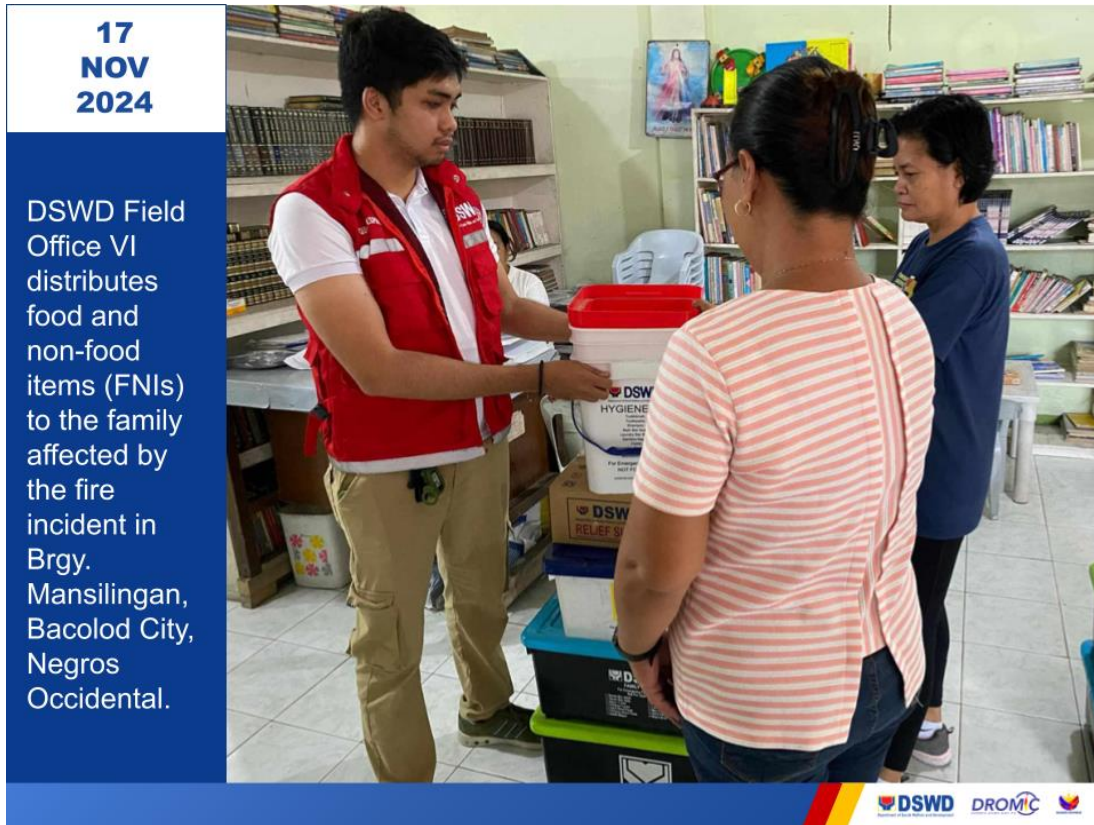
