

DSWD DROMIC Report on the Fire Incident in Brgy. Punao, San Carlos City, Negros Occidental

27 November 2024, 6AM

I. Situation Overview

On 13 September 2024 at around 8:20 AM, a fire incident occurred in Brgy. Punao, San Carlos City, Negros Occidental. The fire was declared out at around 9:15 AM.

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally** damaged in **Brgy. Punao, San Carlos City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,096.00** worth of assistance was provided to the affected family; of which, **₱8,096.00** from **DSWD** and **₱2,000.00** from the **Local Government Unit (LGU)** (see Annex D).
