I. Situation Overview

On 20 August 2024 at around 8:49 PM, a fire incident occurred at Sitio Calambitin, Brgy. San Antonio, Bangued, Abra. The fire was declared out at around 9:49 PM.

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. San Antonio, Bangued, Abra (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P21,162.75** worth of assistance was provided to the affected family composed of **P19,912.75** from **DSWD** and **P1,250.00** from the **Local Government Unit (LGU)** (see Annex D).
