

## **DSWD DROMIC Report on the Fire Incident in Brgy. San Benigno, Aglipay, Quirino**

25 November 2024, 6AM

### **I. Situation Overview**

On 22 October 2024 at around 4:00 AM, a fire incident occurred at Purok 4, Brgy. San Benigno, Aglipay, Quirino. The fire was declared out at around 4:10 AM.

A total of **₱5,165.05** worth of assistance from **DSWD** was provided to the affected families (see Annex D).
