I. Situation Overview

On 22 October 2024 at around 4:00 AM, a fire incident occurred at Purok 4, Brgy. San Benigno, Aglipay, Quirino. The fire was declared out at around 4:10 AM.

Outside Evacuation Center One (1) family or five (5) persons temporarily stayed with their relatives or friends (see Annex B).

One (1) house was **totally damaged** in **Brgy. San Benigno, Aglipay, Quirino** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱5,165.05** worth of assistance from **DSWD** was provided to the affected families (see Annex D).
