I. Situation Overview

On 02 October 2024 at around 9:30 PM, a fire incident occurred in Brgy. San Simon, Bani, Pangasinan.

One (1) house was totally damaged in Brgy. San Simon, Bani, Pangasinan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}25,992.60\$ worth of assistance was provided to the affected family composed of \$\mathbb{P}21,592.60\$ from DSWD and \$\mathbb{P}4,400.00\$ from the Local Government Unit (LGU) (see Annex D).
