





DSWD DROMIC Report on the Fire Incident in Brgy. Sumile, Butuan City, Agusan del Norte

12 November 2024, 6PM

I. Situation Overview

On 10 August 2024 at around 11:00 PM, a fire incident occurred in Brgy. Sumile, Butuan City, Agusan del Norte. The fire was declared out at around 1:00 AM on 11 August 2024.

II. Status of Affected Areas and Population

One (1) family or six (6) persons were affected in Brgy. Sumile, Butuan City, Agusan del Norte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Sumile, Butuan City, Agusan del Norte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱13,582.75 worth of assistance was provided to the affected family; of which, ₱12,382.75.00 from DSWD and ₱1,200.00 from the Local Government Unit (LGU) (see Annex D).
