I. Situation Overview

On 01 November 2024 at around 7:30 PM, a fire incident occurred in Brgy. Tina-an Norte, Leon, Iloilo. The fire was declared out at around 7:40 PM.

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Tina-an Norte, Leon, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱3,170.00** worth of assistance was provided to the affected families; of which, **₱2,670.00** from **DSWD** and **₱500.00** from the **Local Government Unit (LGU)** (see Annex D).
