

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Can-adieng, Ormoc City, Leyte

22 January 2025, 6AM

I. Situation Overview

On 09 November 2024 at around 10:05 PM, a fire incident occurred in Purok 2, Brgy. Can-adieng, Ormoc City, Leyte. The fire was declared out at around 11:29 AM.

In response to the incident, the Department of Social Welfare and Development (DSWD) through its Field Office in Region VIII, provided relief and financial assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **16 families** or **44 persons** were affected in **Brgy. Can-adieng, Ormoc City, Leyte** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

One (1) family or **four (4) persons** sought temporary shelter at the **Covered Court** in **Brgy. Can-adieng, Ormoc City, Leyte** (see Annex B).

b. Outside Evacuation Center

A total of **15 families** or **40 persons** temporarily stayed with their relatives or friends (see Annex D).

c. Total Displaced Population

A total of **16 families** or **44 persons** were displaced in **Brgy. Can-adieng, Ormoc City, Leyte** (see Annex E).

IV. Damaged Houses

A total of **16 houses** were **totally damaged** in **Brgy. Can-adieng, Ormoc City, Leyte** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of **₱267,910.00** worth of assistance was provided by **DSWD** to the affected families (see Annex G).
