

## **DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Mabini, Mainit, Surigao del Norte**

27 January 2025, 6AM

### **I. Situation Overview**

On 25 October 2024 at around 3:20 PM, a fire incident occurred at Purok Daisy, Brgy. Mabini, Mainit, Surigao del Norte. The fire was declared out at around 3:40 PM.

**One (1) family or two (2) persons** were affected in **Brgy. Mabini, Mainit, Surigao del Norte** (see Annex A).

**One (1) family or two (2) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Mabini, Mainit, Surigao del Norte** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱37,646.50** worth of assistance was provided to the affected family; of which, **₱22,646.50** from **DSWD** and **₱15,000.00** from the **Local Government Unit (LGU)** (see Annex D).
