I. Situation Overview

On 16 October 2024 at around 4:00 PM, a fire incident occurred in Brgy. Sto. Niño, Sulat, Eastern Samar. The fire was declared out at around 6:00 PM.

IV. Damaged Houses

A total of **two (2) houses** were totally damaged in **Brgy. Sto. Niño, Sulat, Eastern Samar** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱37,965.76** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
