

DSWD DROMIC Report #1 on the Fire Incident in Brgy. 03, Rosario, Northern Samar

as of 02 December 2024, 6PM

I. Situation Overview

On 22 October 2024 at around 6:20 PM, a fire incident occurred at Aguinaldo St., Brgy. 03 (San Lorenzo), Rosario, Northern Samar. The fire was declared out at around 6:51 PM.

II. Status of Affected Areas and Population

One (1) family or **three (3) persons** are affected in **Brgy. 03 (San Lorenzo), Rosario, Northern Samar** (see Annex A).

III. Status of Displaced Population

a. Outside Evacuation Center

One family or **three (3) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One house was **totally damaged** in **Brgy. 03 (San Lorenzo), Rosario, Northern Samar** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱5,672.50** worth of assistance from **DSWD** was provided to the affected families (see Annex D).
