





DSWD DROMIC Report #16 on Kanlaon Volcano Eruption

as of 17 December 2024, 6PM


I. Situation Overview

- As of 17 December 2024, Kanlaon Volcano remains under Alert Level 3.
- On 09 December 2024 at 3:03 PM, Alert Level 3 was raised from Alert Level 2 over the Kanlaon Volcano after an explosive eruption that occurred at the summit vent. The eruption produced a voluminous plume that rapidly rose to 3,000 meters above the vent and drifted west-southwest. Pyroclastic density currents (PDCs) descended the slopes on the general southeastern edifice based on IP and thermal camera monitors.
- The raising of the Alert Level of Kanlaon Volcano from Alert Level 2 (increasing unrest) to Alert Level 3 (magmatic unrest) means that a magmatic eruption has begun and may progress to further explosive eruptions. All local government units are advised to evacuate the 6-km radius from the summit of the volcano and must be prepared for additional evacuation if activity warrants.

II. Status of Affected Areas and Population

A total of 10,863 families or 44,162 persons are affected in 26 barangays in Regions VI and VII (see Annex A).





III. Status of Displaced Population

a. Inside Evacuation Center

There are 4,852 families or 15,429 persons currently taking temporary shelter in 32 evacuation centers in Regions VI and VII (see Annex B).

b. Outside Evacuation Center

There are **803 families** or **2,711 persons** temporarily staying with their relatives or friends (see Annex E).

c. Total Displaced Population

There are 5,655 families or 18,140 persons still displaced in Regions VI and VII (see Annex F).

IV. Cost of Humanitarian Assistance Provided

A total of ₱37,496,187.53 worth of assistance was provided to the affected families composed of ₱28,982,259.00 from DSWD, ₱8,013,928.53 from the Local Government Units (LGUs), and ₱500,000.00 from Non-Government Organizations (NGOs) (see Annex G).
