

DSWD DROMIC Report #23 on Kanlaon Volcano Eruption as of 21 December 2024, 6AM

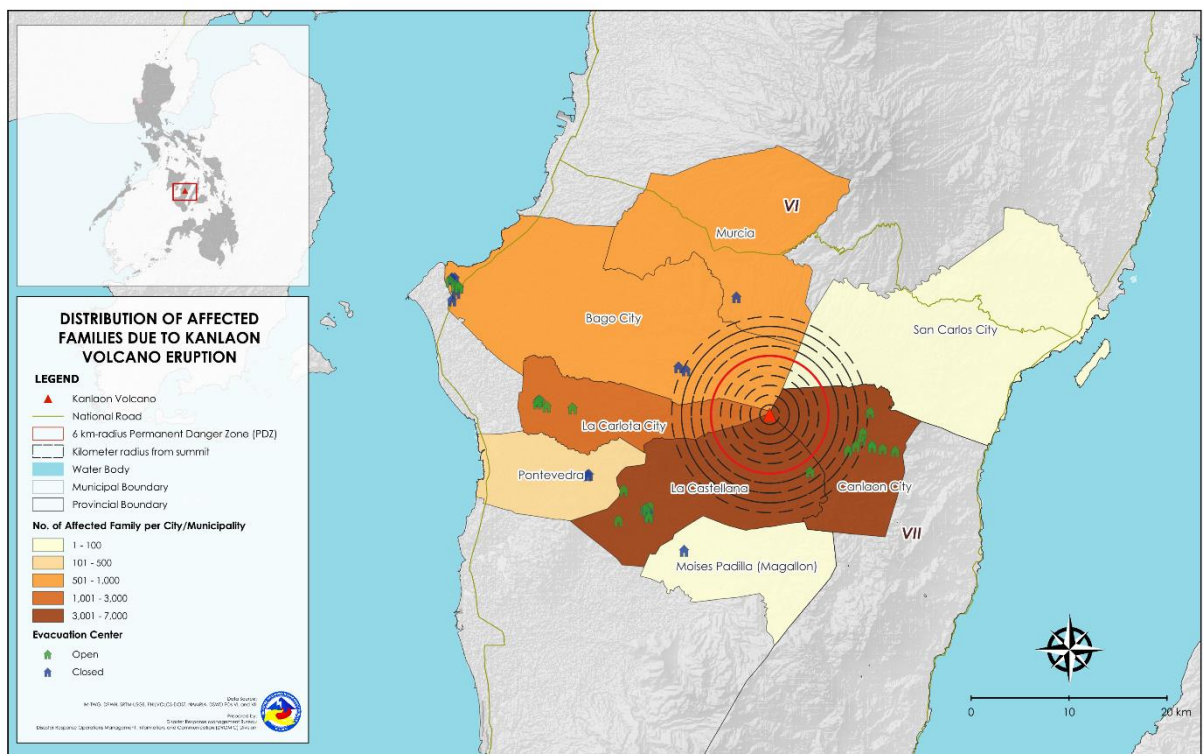
I. Situation Overview

- As of **21 December 2024**, Kanlaon Volcano remains under **Alert Level 3**.
- On 09 December 2024 at 3:03 PM, Alert Level 3 was raised from Alert Level 2 over the Kanlaon Volcano after an explosive eruption that occurred at the summit vent. The eruption produced a voluminous plume that rapidly rose to 3,000 meters above the vent and drifted west-southwest. Pyroclastic density currents (PDCs) descended the slopes on the general southeastern edifice based on IP and thermal camera monitors.
- The raising of the Alert Level of Kanlaon Volcano from Alert Level 2 (increasing unrest) to Alert Level 3 (magmatic unrest) means that a magmatic eruption has begun and may progress to further explosive eruptions. All local government units are advised to evacuate the 6-km radius from the summit of the volcano and must be prepared for additional evacuation if activity warrants.

II. Status of Affected Areas and Population

A total of **11,874 families** or **45,499 persons** are affected in **26 barangays** in **Regions VI** and **VII** (see Annex A).



III. Status of Displaced Population

a. Inside Evacuation Center

There are **4,410 families** or **14,036 persons** currently taking temporary shelter in **31 evacuation centers** in **Regions VI** and **VII** (see Annex B).

b. Outside Evacuation Center

There are **2,014 families** or **6,488 persons** temporarily staying with their relatives or friends (see Annex E).

c. Total Displaced Population

There are **6,424 families** or **20,524 persons** still displaced in **Regions VI** and **VII** (see Annex F).

IV. Cost of Humanitarian Assistance Provided

A total of **₱53,057,017.94** worth of assistance was provided to the affected families composed of **₱43,519,719.41** from **DSWD**, **₱8,537,298.53** from the **Local Government Units (LGUs)**, and **₱1,000,000.00** from **Non-Government Organizations (NGOs)** (see Annex G).
