There are **17 families** or **76 persons** temporarily staying with their relatives or friends (see Annex C).

c. Total Displaced Population

There are **769 families** or **2,806 persons** still displaced in **Regions II, V, VI, and VII** (see Annex D).

IV. Damaged Houses

A total of **49 houses** were damaged; of which, **13** are **totally damaged** and **36** are **partially damaged** in **Regions V, VII and VII** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱3,575,483.89** worth of assistance was provided to the affected families; of which, **₱2,531,983.89** from **DSWD** and **₱1,043,500.00** from the **Local Government Units (LGUs)** (see Annex F).
