

DSWD DROMIC Report on the Armed Conflict in Brgy. Gatuslao, Candoni, Negros Occidental

27 December 2024, 6AM

I. Situation Overview

On 21 November 2024 at around 3:40 AM, an armed conflict transpired between the security patrol operations troops of 47th and 15th Infantry Battalion and alleged members of the Communist Party of the Philippines-New People's Army (CPP-NPA) in Brgy. Gatuslao, Candoni, Negros Occidental.
