

## **DSWD DROMIC Report on the Armed Conflict in Brgy. Gatuslao, Candoni, Negros Occidental**

27 December 2024, 6AM

### **I. Situation Overview**

On 21 November 2024 at around 3:40 AM, an armed conflict transpired between the security patrol operations troops of 47<sup>th</sup> and 15<sup>th</sup> Infantry Battalion and alleged members of the Communist Party of the Philippines-New People's Army (CPP-NPA) in Brgy. Gatuslao, Candoni, Negros Occidental.
