I. Situation Overview

On 14 November 2024 at around 10:00 PM, a fire incident occurred at Purok 4, Brgy. Aguisan, City of Himamaylan, Negros Occidental.

One (1) house was totally damaged in Brgy. Aguisan, City of Himamaylan, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱17,486.00** worth of assistance was provided to the affected family composed of **₱7,486.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
