I. Situation Overview

On 26 November 2024 at around 1:50 PM, a fire incident occurred in Brgy. Bantayan, City of Kabankalan, Negros Occidental.

II. Status of Affected Areas and Population

One (1) family or five (5) persons were affected in Brgy. Bantayan, City of Kabankalan, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Bantayan, City of Kabankalan, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱7,598.00 worth of assistance was provided to the affected family; of which, ₱6,198.00 from DSWD and ₱1,400.00 from the Local Government Unit (LGU) (see Annex D).
