I. Situation Overview

On 01 November 2024 at around 6:49 PM, a fire incident occurred in Brgy. Botongon, Estancia, Iloilo. The fire was declared out at around 7:30 PM.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Botongon, Estancia, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P11,176.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
